The following shall be the scheme of examination, components of written test and its syllabus etc. for the post of Senior Assistant through limited departmental examinations.

Note:

- The question paper should be bilingual (English and Hindi) and the applicant will have the option to respond in either of the languages. However, the same the medium of language must be used throughout.
- The minimum qualifying marks will be overall 40% for the unreserved posts and 35% for reserved posts (i.e. for SC/ST/PwD category as applicable).
- 3. The level of the question will be as per the work profile of the post concerned for which the test is being conducted.
- The APAR and eligibility conditions of the successful candidates will be scrutinized by a Committee of Officers comprising of the following:
 - · Officer Incharge of the Establishment of the Non-teaching
 - Officer Incharge of the Recruitment Section
 - · Officer Incharge of College Branch
 - · Officer Incharge of the Vigilance Section
 - Section Officer of the respective Establishment and Recruitment Sections.
- A panel shall be created on the basis of the written exam and due vetting by the committee detailed above, which shall be valid for a period of one year or till the time the number of posts is filled on the basis of available names from the panel, whichever is earlier.
- The test will be held every year/once in two years depending upon the number of vacancies in a year. In case these are no vacancies in a particular year, no test will be held.
