Aryabhatta College in collaboration with Advance Institute of Financial Markets & Research (AIFMR) is offering an Add-on course titled “**Advance Skill Programme on Financial Markets**” (ASPFM), certified by **National Institute for Entrepreneurship and Small Business Development (NIESBUD)**, a premier Organisation of Ministry of Skill Development and Entrepreneurship, Government of India.

The course has been especially designed to equip students with specialized skills needed to work with the ever increasing challenges of the financial markets.

The details regarding admission are as follows:

Eligibility and Course Fee:

Pursuing Graduation with at least 60% marks (last examination passed) or Class 12 (at least 70% marks)*.

The course is open to all the students of Aryabhatta College and other colleges of University of Delhi**.

The course fee per student is **Rs. 16,500** payable through Demand Draft in favour “**PRINCIPAL, ARYABHATTA COLLEGE**” payable at Delhi.

Duration of the Course:

The total duration of the course is 100 hours (around 4-5 months). Classes would be held in the college premises, three days a week, starting from 17th September, 2018. Classes will be suspended during Delhi University Examinations.

Course structure:

Study material and the faculty would be provided by AIFMR.

A student would become eligible to receive the certificate on completion of the following: (a) by scoring at least 60% marks in each of the two examinations; Mid-term examination and End-term examination, and (b) maintaining at least 70% attendance. All these examinations would be held in the Aryabhatta college premises.

The certificate will be issued jointly by Aryabhatta College & AIFMR and NIESBUD on successful completion of the course.

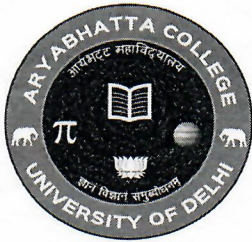

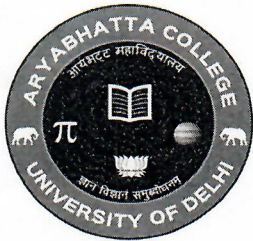
