The details regarding admission are as follows:

Eligibility and Course Fee:

Pursuing Graduation (at least 60% Marks {last examination passed} or Class 12 with at least 70% marks*.

The course is open to all the students of Aryabhata College and other colleges of University of Delhi**.

The fee per student is **Rs. 20,000 (inclusive of NSE Examination Fee)** payable through Demand Draft in favour “**PRINCIPAL, ARYABHATTA COLLEGE**” payable at Delhi.

Duration of the Course:

The duration of the course is 100 hours (around 4-5 months).

Classes will be held during Saturday and Gazetted Holidays.

Classes will be suspended during Delhi University Examinations.

Classes would be held in the college premises, from 9:30 a.m. onwards (4 Hours per day) starting from 17th August, 2019.

Course structure and Certification:

Study material, online material and the faculty would be provided by IMS Proschool.

Students are required to bring their laptop for course sessions. ***

A student would become eligible to receive the certification on completion of the following:

Course Completion Certificate issued jointly by Aryabhata College and IMS Proschool {80% attendance and 80 % marks (5 internal exams)}.

NSDC Certificate issued jointly by IMS Proschool and National Skill Development Corporation (NSDC) on the successful completion of the course and by passing the examination, which will be conducted by IMS Proschool {80% attendance and 80 % marks (5 internal exams)}.

NSE Academy's Certification (Financial Modeling) issued jointly by NSE Academy and IMS Proschool only if student successfully passed the end term examination conducted at NSE Centre, Delhi. Certification from NSE India is valid for lifetime.

Internal examination would be held at Aryabhata College and End Term examination at NSE Centre, Delhi.
