- The candidate is required to mention his/her residential address along with contact number on the backside of the Nomination Form.

- Only II and III year students will be eligible to contest for the post of President and Secretary.

- 55% marks in the last examination passed (CGPA based on multiply X 9.5)

- No Essential Repeat in the previous University examination (No Backlog of Papers)
- The candidate should be between the age of 17 to 22 years as on 16th August, 2019.
- Every candidate is required to furnish an affidavit to the effect:
- (i) that he/she does not have any previous disciplinary record and has not been subjected to any disciplinary action by the University/College.
- (ii) that he/she has not failed in the preceding academic year and/or re-admitted in the current year
